Unless earlier forfeited under the terms of the RSU, the RSU will vest as follows: (a) 40% of the RSUs vest and convert into common stock on the first anniversary of the grant date (which grant date is October 26, 2022), (b) 30% of the RSUs vest and convert into common stock on the second anniversary of the grant date and (c) 30% of the RSUs vest and convert into common stock on the third anniversary of the grant date. If a vesting date falls on a non-business date, the next business date shall apply.

3. Unless earlier forfeited under the terms of the RSU, 100% of the RSUs vest and convert into common stock on the six-month anniversary of the grant date (which grant date is October 26, 2022) (or next business date, if applicable).
